



Completion

- ◆ all projects must be completed within 12 months of the award of a grant
- ◆ in some circumstances an interim report may be required
- ◆ for the current awarding year completion must be by 31st August 2018
- ◆ requests for extensions will be considered only in exceptional circumstances
- ◆ where appropriate the report should contain as many photographs as possible
- ◆ the report may or may not be published in a scientific or academic journal, but in all circumstances the report, or a derivation from it, must be available for publication in the Cyclamen Society Journal
- ◆ all published material must acknowledge the support of the Cyclamen Society
- ◆ full accounts must be presented as part of the report, detailing how the grant has been spent
- ◆ an award may be used to part fund a project or match fund a project

Grant Awards Information

Thank you for taking the time and trouble to read these notes.

The Cyclamen Society Trustees have established this fund, worth £10,000 per year, to support the Society in fulfilling its aims to enhance our knowledge of the genus Cyclamen.

It may be helpful to give one or two examples of the sorts of projects we might be interested in funding.

If, for example, you were interested in developing a new method for counting chromosomes in a species of plant completely unrelated to Cyclamen, we would be interested in supporting you. Equally, if you were investigating the distribution of a species of plant and your area of activity included places where Cyclamen grew, we may well be interested in supporting you if you extended your work to include Cyclamen.

We very much hope that you will wish to apply for a grant and be part of the process of taking our knowledge and understanding of Cyclamen further.

Applications

Applications are invited for the year 01 September 2016 to 31 August 2017 from individuals, groups and organisations. Applicants are not required to be members of the Cyclamen Society.

Please note:

Applications **must** be written and submitted:

- ◆ on the standard form
- ◆ by the closing date

No applications will be considered after the closing date.

Application packs are available from 01 September 2016. Applicants have about 6 months or so for completion and submission of their application.

Decisions will be made to enable funding to be available from the September following submission.

Closing date: 30th April 2017

Decisions by the Awards Committee advised by: 31st July 2017

Awarding Criteria

- ◆ no individual grant may exceed £5000
- ◆ the project must relate to new or to a new dimension of existing work
- ◆ the project must involve research relating to Cyclamen;

The focus on Cyclamen may be direct or indirect, but in order to achieve funding, the application must be able to satisfy the Awards Committee that there will be some improvement in our knowledge and/or understanding of Cyclamen.

Payment

- ◆ the grant will usually be awarded on the submission of invoices, either paid or unpaid
- ◆ in the case of paid invoices, expenditure must be approved in advance by the Awards Panel or reimbursement may be refused
- ◆ payments can be phased as required, or paid in full at the conclusion of the project
- ◆ the grant may be used for any purpose relating to the project
